ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED INCORPORATOR OF THESE ARTICLES OF INCORPORATION IS A
NATURAL PERSON COMPETENT TO CONTRACT AND HEREBY FORMS A
CORPORATION FOR PROFIT UNDER THE GENERAL CORPORATION ACT AND OTHER
LAWS OF THE STATE OF FLORIDA.

ARTICLE I. NAME

THE NAME OF THE CORPORATION IS FIRST COAST PRESSURE WASHING, INC

ARTICLE II. COMMENCEMENT

THIS CORPORATION WILL EXIST EFFECTIVE MARCH 10, 2001

ARTICLE III. DURATION

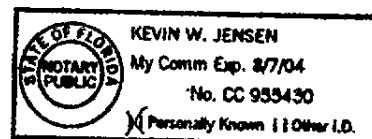
