ARTICLE I - NAME

The name of this corporation is: YOU & YOU TOO, INC., with the principal place of business located at: 9473 SOUTH DIXIE HWY, MIAMI, FL. 33156.

ARTICLE II - PURPOSE

This corporation shall have perpetual existence and may engage in any and all lawful business under the laws of the United States and the State of Florida.

ARTICLE III - CAPITAL STOCK
