## ARTICLES OF INCORPORATION

s hereby act as Articles of

The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "Corporation") is WHISPER ARTS PRODUCTIONS, Inc.

SECOND: The address, wherever located, of the principal office of the Corporation is, if known, is 9423 Bluebird Drive, Tampa FL 33647.
