We, the undersigned, as proper persons acting as incorporators of a corporation under the laws of the State of FLORIDA, adopt the following articles of incorporation:

**FIRST**

The name of the corporation is ALL WEST PALM FENCE CO., INC.

**SECOND**

The period of its duration is PERPETUAL

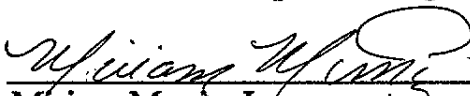
