ARTICLES OF INCORPORATION

The undersigned subscribes to these Articles of Incorporation for the purpose of forming a corporation pursuant to the provisions of the Florida Business Corporation Act, Chapter 607, <u>Florida</u> Statutes.

ARTICLE I NAME AND ADDRESS
