ARTICLES OF INCORPORATION OF

JS Macdonald Inc.

ARTICLE 1 - Name

The name of the corporation is: JS Macdonald Inc.

ARTICLE II – Existence

This corporation shall commence existence upon receipt and filing of these articles.

ARTICLE III – Purpose
