The undersigned, for the purposes of engaging and organizing a corporation under the laws of the State of Florida, does hereby associate herself and adopt the following Articles of Incorporation for such corporation:

I. **NAME**: The name of the corporation shall be The Dance Factory, Inc. and it is to be located at Forest Oaks Plaza, U. S. Highway 19 North, Spring Hill, Hernando County, Florida 34606.

II. **BUSINESS PURPOSE**: The nature and purpose of the corporation will be to own and operate a dance school including tap, ballet, jazz, lyrical, modern and acrobatic instruction business and all other activities associated with the business. The corporation shall be authorized and able to do all lawful business which the laws of the State of Florida allow for corporations organized under the laws of the State of Florida.

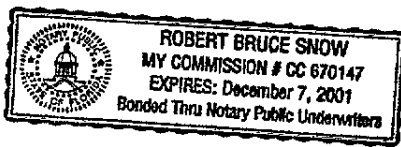
