For the purpose of forming a corporation under Florida law, the incorporator hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation is FOUR J VILLAGE, INC.

ARTICLE II. DURATION

The duration of this corporation shall be perpetual.

ARTICLE III. PURPOSE

The purpose of this corporation shall be to operate a mobile home park, and all other lawful business for which a corporation may be incorporated under the Florida General Corporation Act.
