**ARTICLES OF INCORPORATION  
OF  
SATELLITE INSTALLERS OF AMERICA, INC.**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

**ARTICLE I  
(Name and Mailing Address)**

The name of the corporation is SATELLITE INSTALLERS OF AMERICA, INC., and its mailing address is 3727-B, Del Prado Boulevard, Cape Coral, Florida 33904.

**ARTICLE II  
(Duration)**

The duration of this corporation is perpetual and its existence shall commence on the date of execution and acknowledgment of these Articles.

**ARTICLE III  
(Purpose)**

The general purposes for which this corporation is organized are to install satellite dishes and systems throughout Florida; to sell satellite dishes and ancillary equipment; to engage in such other activities as are incidental to or connected with the operation of such business; and to transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

**ARTICLE IV  
(Capital Stock)**

This corporation is authorized to issue 10,000 shares of common stock with a par value of \$1.00 per share.

**ARTICLE V  
(Initial Registered Office and Registered Agent)**

The street address of the initial registered office of this corporation is 2248 First Street, Fort Myers, FL 33901, and the name of the initial registered agent of this corporation at that address is Robert A. Winesett.

**ARTICLE VI  
(Preemptive Rights)**

Every Shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

**ARTICLE VII  
(Initial Board of Directors)**

This corporation shall have two directors initially. The number of Directors may be either increased or diminished from time to time by a majority of the shareholders present in person or by proxy at any annual or special meeting of the shareholders but shall never be less than one director nor more than seven directors. 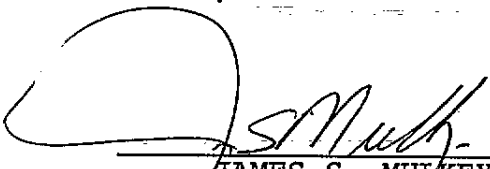
**ARTICLE X  
(Bylaws)**

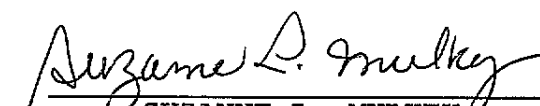

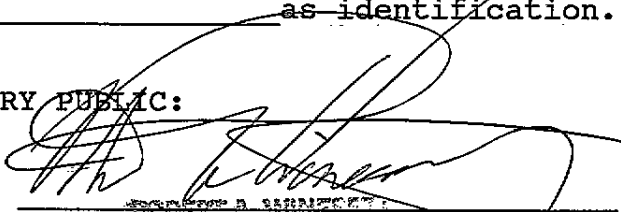

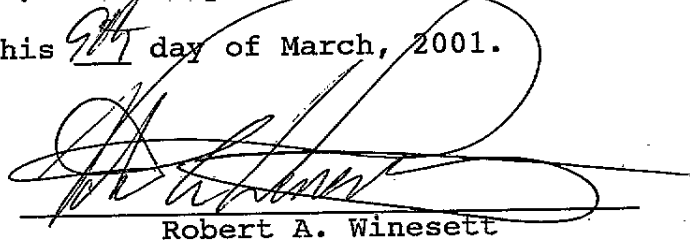
