The undersigned subscriber to these Articles of Incorporation, Terri L. Sheppard, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of this Corporation is TERRI L. SHEPPARD, INC. The principal office and mailing address of the corporation is 26970 Villanova Court, Bonita Springs, Florida 34135.

ARTICLE II

DURATION

The Corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.

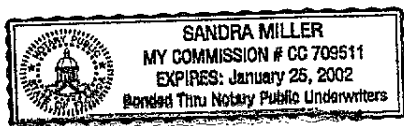
