ARTICLES OF INCORPORATION

of

The undersigned Subscriber(s) to these Articles of Incorporation, natural person(s) competent to contract, hereby form(s) a corporation for profit under the laws of the State of Incorporation.

ARTICLE I - NAME

The name of this corporation is REGULATORY RESOURCE, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence and shall be effective upon filing of the Articles of Incorporation by the Department of State.
