1. The name of this Corporation is SHIFTER'S TRANSMISSIONS, INC.
2. The Articles of Incorporation for this Corporation were filed on March 12, 2001 and assigned Florida Document Number P01000026956.
3. The Articles of Incorporation of SHIFTER'S TRANSMISSIONS, INC. have been amended by deleting Article I in its entirety and by substituting the following in lieu thereof:

**"ARTICLE I – NAME**


The name of this Corporation is LaVorgna Holdings, Inc."
