ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is Internet Data Management Corporation, Inc., and the principal address is 36468 US Hwy 19 North, Palm Harbor, FL 34684.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is 36468 US Hwy 19 North, Palm Harbor, FL 34684. The name of its registered agent at such address is Michael R. Bittel.

ARTICLE III - PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of the State of Florida.
