**ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is H & M CONSULTING, INC. and its principal place of business shall be located at 8763 NW 35<sup>th</sup> St., Coral Springs, FL 33065..

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV - CAPITAL STOCK**

#### ARTICLE X - INDEMNIFICATION

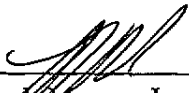
