ARTICLES OF INCORPORATION OF JON-DELS AUTO REPAIR, INC.

#### ARTICLE 1. - NAME

The name of this corporation is JON-DELS AUTO REPAIR, INC.

# ARTICLE 2. - DURATION

This corporation shall exist perpetually unless dissolved according to Florida law.




