

ARTICLE I - NAME AND ADDRESS

The name of this corporation shall be **Suncoast Properties of the Islands, Inc.**, A Florida Corporation. The principal office of the corporation is 1640 Periwinkle Way, Suite V, Sanibel Island, FL 33957; the mailing address of the corporation is Post Office Box 214, Sanibel Island, FL 33957.

ARTICLE II - TERM OF EXISTENCE

This corporation is to have perpetual existence.

ARTICLE III - PURPOSE

The general nature of the business to be transacted by this corporation shall be as follows:

- A. To organize and operate a real estate investment company in the State of Florida.
- B. To transact any and all lawful business in the State of Florida pursuant to Florida Statutes, Chapter 607.
