When trying to file an Annual Report for the above referenced corporation, I realized that it has been Administratively Dissolved. I called to check on this and was told that your office had sent out a letter requesting more information (no Employer Identification Number on report) in 2003. The client re-sent the Annual Report with a EIN, that was apparently wrong.
