ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF PARTNER MARKETING, INC.

1. Article VIII of the Articles of Incorporation of Partner Marketing, Inc. is amended to read as follows:

ARTICLE VIII. DIRECTORS

All Corporate powers shall be exercised by or under the authority of, and the business and affairs of the corporation managed under the direction of its Board of Directors, subject to any limitation set forth in these Articles of Incorporation.

The number of directors constituting the initial Board of Directors of the Corporation is two (2) which may be increased or decreased by the bylaws.

- 2. The foregoing Amendment was adopted by the sole Incorporator of this Corporation on the 4th day of April, 2001 without shareholder approval.
- 3. Shareholder approval was not required for the foregoing Amendment.
