ARTICLE I. NAME

THE NAME OF THIS CORPORATION IS CROWN TRUCKING, INC.

ARTICLE II. COMMENCEMENT

THIS CORPORATION WILL EXIST EFFECTIVE MARCH 15, 2001.

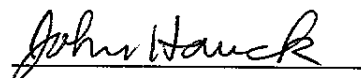

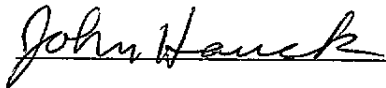
