# ARTICLES OF INCORPORATION OF: Blue Light Services Corp.

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

#### <u>ARTICLE I - NAME</u>

The name of this corporation is **Blue Light Services Corp.** (Hereinafter, "Corporation")

#### ARTICLE VII AMENDMENT

These articles of Incorporation may be amended in the manner provided by law.
