ARTICLES OF INCORPORATION OF TAMA JORDAN ENTERPRISES, INC.

The undersigned hereby makes, subscribes, acknowledges, and files this certificate for the purpose of becoming a corporation for profit under the laws of the State of Florida.

- 1. Name. The name of this corporation (the "Corporation") shall be:  
TAMA JORDAN ENTERPRISES, INC.
- 2. Address. The initial street address of the principal office of this Corporation is 296 Stahlman Ave. Destin, FL 32541 and Tama Jordan, 296 Stahlman Ave. Destin, FL 32541 is hereby designated as the registered agent for this Corporation.
- 3. Purpose. This Corporation is in the business of nurse anesthetist as permitted under the laws of the United States and of this State.


