ARTICLES OF INCORPORATION

ARTICLE I

The name of this corporation is LAURADINO, INC.

These shares nor any part hereof shall be sold or otherwise transferred to any person other than the person to whom originally issued, his or her heirs, executors or administrators, unless first submitted to LAURADING. INC., (the Company) for redemption at the then fair market value. In the event that the Company shall fair or refuse to redeem such shares within ninety days following the tender thereof to the Company, then and in that event, the person to whom such shares were originally issued shall be authorized to dispose of such shares or any part thereof in any manner permitted by unless entered in the records of the Company.

The transfer of any shares of stock hereafter issued shall not be effective unless approved in writing by the stockholders.
