ARTICLES OF INCORPORATION OF
LAND CAPTAIN INC.

ARTICLE I

The name of the corporation shall be: LAND CAPTAIN INC.

ARTICLE II

The corporation shall engage in any activity permitted by the State of Florida and the United States of America.
