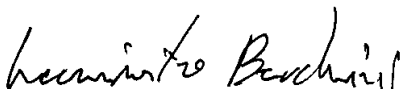
I do not ignore letters or bills sent to me. I certainly would have brought it to the attention of my bookkeeper if I had received something that I did not know what it was.
