The undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida.

Article I Name of Corporation

The period of the corporation's duration is perpetual.

Article III General Purpose

This corporation is organized for the purpose of transacting any and all lawful business, including but not limited to, trucking and hauling services.
