

ARTICLES OF INCORPORATION

OF

CONNEAH , In C.

ARTICLE I - NAME

The name of the Corporation shall be CONNEAH, INC. a Florida Corporation.

ARTICLE II - PURPOSE

This Corporation is organized for the purpose of transacting any, all lawful business, and perpetual existence.

ARTICLES III - POWERS

This Corporation shall have all of the powers enumerated in the "Florida General Corporation Act", (Chapter 607, Florida Statues).

To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets;

To lend money, and use its credit to assist, its officers and employees in accordance with Florida Statue S607.141;

To purchase, take, receive, subscribe for, or otherwise acquire, own, hold vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, share of other interests in, or obligations of, other domestic or foreign corporations, associations, partnerships, or individuals, or direct or indirect obligations of the United States or of any other government, state, territory, governmental district, or municipality or of any instrumentality thereof;

To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income;

To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security of the payment of funds so loaned or invested;

To transact any lawful business which this Board of Directors shall find will be in aid of governmental policy;

To pay pensions and establish pension plans, profit sharing plans, stock bonus plans, stock option plans, and other incentive plans for any or all of its directors, officers, and employees of its subsidiaries;

To be a promoter, incorporator, partner, member, associate, or manager of any corporation, partnership, joint venture, trust, or other enterprise; To indemnify any person who by reason of the fact that he is or was a officer, employee or agent of the corporation to the full extent as permitted by Florida Statue S607.014;

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue 10,000 shares of voting common stock (one thousand shares), with a par value of \$1.00 (one dollar) per share. Unless otherwise stated in these articles, or in an amendment of these articles, there shell be only one (1) class of stock of this corporation.


