The undersigned subscribers to these Articles of Incorporation are natural persons competent to contract and hereby authorized to register for a corporation for profit under Chapter 607 of the Florida Statutes.

**ARTICLE 1 – NAME**

The name of the Corporation is **H. & R. RACING, INC.**

**ARTICLE 2- PURPOSE OF CORPORATION**

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE 3- PRINCIPAL OFFICE**

The address of the principal office of this Corporation is 5470 W. 10<sup>th</sup> Ave. Hialeah, Fl. 33012.

**ARTICLE 4 - INCORPORATORS**

**ARTICLE 5 – PRESIDENT**

The initial President of the Corporation shall be **RAIZA RUIZ**, whose address shall be the same as the principal office of the Corporation.
