ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

Article I - Name

The name of this Corporation is NUMERO UNO TOBACCO COMPANY. The principal place of business of this Corporation shall be 13014 N. Dale Mabry Hwy #337, Tampa, Florida 33618 or such other place as may be designated by the Board of Directors.

Article II - Capital Stock
