**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporations Act, hereby adopts the following Articles of Incorporation.

FIRST: The name of the corporation is TLC Vision Associates of Florida, P.A.

SECOND: The purposes for which the Corporation is formed are:


FOURTH: The number of shares the corporation is authorized to issue is one hundred (100).


