


ARTICLE IX. REGISTERED OFFICE AND REGISTERED AGENT

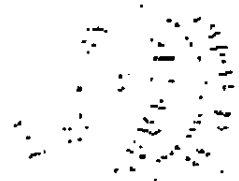
