



ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is B TO Z MARKET AND DISCOUNT BEVERAGE, INC.



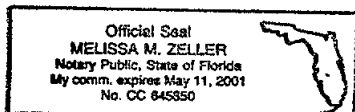


