### ARTICLES OF INCORPORATION OF HAIR BIZ OF THE TREASURE COAST INC.

ARTICLE 1. NAME

The Name of this Corporation is HAIR BIZ OF THE TREASURE COAST INC.

ARTICLE II. DURATION

This Corporation is to have perpetual existence.
