**ARTICLES OF INCORPORATION
OF BIANCA FASHION, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I -- NAME

The name of this corporation shall be: BIANCA FASHION, INC.

ARTICLE II -- PURPOSE

This corporation is organized for the transaction of any and all lawful business for which corporations may be incorporated in the State of Florida.

ARTICLE III - CAPITAL STOCK

ARTICLE VI -- INITIAL REGISTERED AGENT AND STREET ADDRESS

ARTICLE VII - INITIAL BOARD OF DIRECTORS

The Articles of Incorporation may be amended as provided by law.

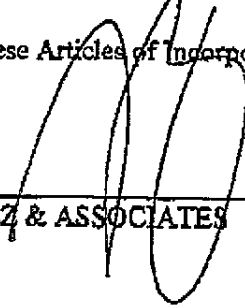
ARTICLE XII - VOTING RIGHTS
