

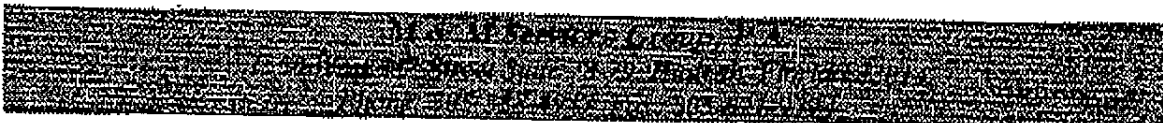
ARTICLE XI- AMENDMENT
