# ARTICLES OF INCORPORATION

OF

# KABC PARTNERS, INC.



#### ARTICLE I

The name of this Corporation shall be KABC PARTNERS, INC.

#### ARTICLE II

This Corporation shall exist in perpetuity.

# ARTICLE III
