ARTICLES OF INCORPORATION

We, the undersigned, as proper persons acting as incorporators of a corporation under the laws of the state of Florida, adopt the following articles of incorporation:

FIRST The name of the corporation is: Holcher and Company, P.A., Certified Public Accountants.

SECOND The period of its duration is: indefinite.

THIRD The purpose of the corporation is: provide Certified Public Accounting services as provided for in the Florida statutes.

FOURTH The aggregate number of authorized shares is: 10,000.

FIFTH The corporation will not commence business until at least \$100 dollars have been received by it as consideration for the issuance of shares.

SIXTH Cumulative voting of shares of stock 10,000 authorized.

SEVENTH Provisions limiting or denying to shareholders the pre-emptive right to acquire additional or treasury shares of the corporation are: to be determined later

EIGHTH Provisions for regulating the internal affairs of the corporation are: whatever is allowed under the Professional Association statutes of Florida.
