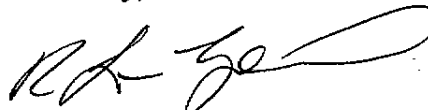

ARTICLES OF INCORPORATION
OF
SANTA ROSA LAWN & LANDSCAPE, INC.

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act and providing for the formation, rights, and privileges of corporations for profit, hereby adopts the following Articles of Incorporation for such corporation;

ARTICLE I
NAME

The name of the corporation shall be SANTA ROSA LAWN & LANDSCAPE, INC., and its principal place of business shall be in the county of Santa Rosa, Florida, but it shall have the power and authority to establish branch offices at such places as may be designated by the Board of Directors.

ARTICLE II
EFFECTIVE DATE

The corporation shall begin its existence on March 31, 2001.

ARTICLE III
DURATION

The period of duration for this Corporation is perpetual.

ARTICLE IV
PURPOSE

The purpose of the Corporation is lawn care, maintenance and landscaping, and to engage in any business as permitted under the laws of the United States and the State of Florida, and to do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes herein set forth.

ARTICLE V
CAPITAL STRUCTURE

The corporation shall have authority to issue one thousand (1000) shares of common stock, all of one class, one dollar (\$1.00) par value per share.

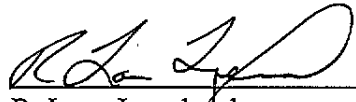
ARTICLE VI
