THE UNDERSIGNED ESTABLISHES THE FOLLOWING FOR THE PURPOSES OF THE PROVISION UNDER THE LAWS OF THE STATE OF THE PROVISION OF T BECOMING A CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA, BY AND UNDER THE PROVISIONS OF THE STATUTES OF THE STATE OF FLORIDA PROVIDING FOR THE FORMATION, LIABILITY, RIGHTS, PRIVILEGES AND IMMUNITIES OF A CORPORATION FOR PROFIT.

## ARTICLE I
