ARTICLES OF INCORPORATION

EFFECTIVE DATE

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

## ARTICLE ONE:

The name of the Corporation is MIGHTY T. REALTY, INC.

## ARTICLE TWO:

The duration of the corporation is perpetual with commencement effective April 1, 2001.

# ARTICLE THREE:

The general purposes for which the corporation is organized are:

- 1. To engage in any or all of the aspects of real estate investment.
