I am writing on behalf of the taxpayers above, regarding your request for a 2002 Uniform Business report, and applicable fees.

The taxpayer forwarded your request to me last week. The taxpayer has stated that this is the only inotification they recall receiving regarding a request for filing. In addition, a request was only received for Vater & Vater Real Estate Corp., no request has yet been received for C&N Real Estate Corp. Note these corporations were formed to hold real estate, but as of the end of the year 2001, real estate titles had not been transferred, and both were inactive entities. We timely filed inactive "-0-" federal returns for each, along with Florida Corporate Income Form CCH1. I have enclosed copies for your use.

I spoke with your office on Friday regarding your filing requirements. If the taxpayer had realized that these inactive corporations were required to file your report, they would have complied timely, as they did with those mentioned above. I have updated their tax records here to include your annual filing requirement so that future reports will be remitted timely. As such, we are requesting that you process the forms for these inactive entities with the initial \$150 fee that would have been due if filed by May 1. Because we did not receive a preprinted form for C&N, I have enclosed a computer-generated form.
