

This corporation shall have perpetual existence and this existence shall commence on the date of March 7, 2001.

ARTICLE ONE

ARTICLE SIX



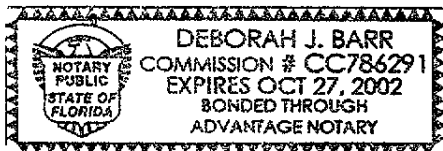
