## ARTICLES OF INCORPORATION

OF

# FLORIDA STAR FLEET SERVICES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

# ARTICLE - NAME

The name of the Corporation is **FLORIDA STAR FLEET SERVICES**, **INC.** Its business location shall be 2756 W. Atlantic Boulevard, Suite 16, Pompano Beach, Florida 33069.


