ARTICLES OF INCORPORATION

OF

GREAT WHITE ENTERPRISES OF BREVARD, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Herid Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the Corporation shall be GREAT WHITE ENTERPRISES OF BREVARD, INC.

ARTICLE II
