of

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE - VIII - DIRECTORS


The business and affairs of the corporation shall be managed by a Board of Directors. The number and composition of which Board shall from time to time be established by the Shareholders.



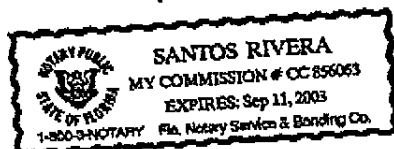
