The undersigned, acting as Incorporator of **J. J. K. AND N., CORPORATION** (the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME AND PRINCIPAL OFFICE

The name of the Corporation is **J. J. K. AND N., CORPORATION**, and the street address of the initial principal office of the Corporation is 2485 University Drive, Coral Springs, Florida 33065.

ARTICLE II

PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE III

CAPITAL STOCK

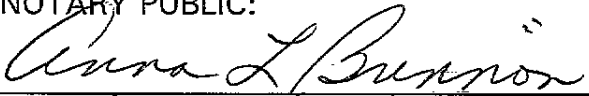
