
ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
ACRYLICRETE COATINGS, INC.

Article I of the Articles of Incorporation of ACRYLICRETE COATINGS, INC. was amended by the corporation's board of directors on January 31, 2007. The corporation is filing these articles of amendment to articles of incorporation pursuant to Fla. State. 607.0602.
