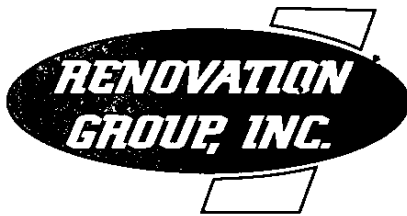

In July of 2001, we opened our Corporation. I did so with a Law Firm called Utrera & Spiegel P.A. . I paid for substantial fees for them to not only set it but to also perform the corporate maintenance required. We also set them up as advised by one of their lawyers to have the firm function as registered agent for the corporation to perform these matters.

It was brought to my attention today 2-1-2005 by my bank management personnel that there is a serious problem with the corporation status. I am unfamiliar with this process, which is why I hired the firm to be the registered agent to take care of these matters. We also took the initiative to sign up with the law firm and pay additional fees for them to keep us apprised of legal matters of this kind that we would otherwise not know that we had to do. I discovered that the corporation was dissolved in 2002. I was never aware that the law firm had not performed our corp yearly filing.

Upon trying to contact the law firm today I discovered that they no longer conduct business in the office address that I had on file. To my shock they were no longer at that address and had not been for 3 whole years. The telephone number although the same was now assigned to another company who had nothing to do with this law firm. They were very aggravated and annoyed even on the nasty side because they are being hassled by old Spiegel and Otrera clients who are also looking for them as I was. I also have never received any notices regarding this matter because they never updated our address with your main data file either. The last time that I contacted Spiegel & Utrera, PA was in 2002 to provide our new address should they need it. Your records show the old address from 2001. There has been a severe breakdown in communication and the Law Firm that I had contracted has disappeared. They are gone and I had no idea what was snowballing into a corporate problem until today.

I am submitting this request for a pardon on the penalty fee of \$600.00. I am sending all of the filing fee payments and signed forms that must be processed to reinstate our corporation. I am respectfully requesting that the Penalty Fee of \$600.00 be waived. Thank for looking into this matter and reviewing the details and hopefully assisting me with this problem. I still believe in fair and due justice by people in our system. Can you help me? If you can not will you please put my letter in the hands of the right person in your department that can?
