ARTICLE I - NAME

The name of this Corporation is LAS OLAS GRAND DEVELOPMENT CORP. II.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing as of March 20, 2001.


ARTICLE X - INDEMNIFICATION

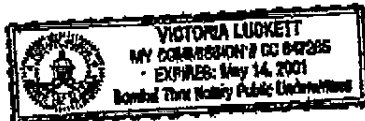




