ARTICLES OF INCORPORATION SOMETHING TO TALK ABOUT TOO, INC.

St. MAR 19 AM 11. 20 The undersigned, acting as incorporator of a corporation for profit under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I.

The name of this corporation is **SOMETHING TO TALK** ABOUT TOO, INC. and the principal place of business shall be 34904 Emerald Coast Parkway-Suite 132, Destin, FL 32541.

ARTICLE II.

DURATION: The corporation shall exist perpetually.

ARTICLE III.

PURPOSE: The purpose or purposes for which this corporation is organized is to engage in operating an retail sales of clothing and accessories, and/or any activity or business permitted under the laws of the United States and the State of Florida. shall be a general purpose corporation.
