ARTICLE I - NAME

The name of the corporation shall be JTM Deliveries, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal office and mailing address of the corporation is 14451 S.W. 124 Place, Miami, Florida 33186.

ARTICLE III - PURPOSES

The purpose or purposes for which the corporation is organized is to engage in any activity or business permitted under the laws of the United States and of this State, and to do everything necessary, proper, advisable or convenient for the accomplishment of said purposes, and to do all other things incidental to them or by other law, or by these Articles of Incorporation, and to carry out the said purposes in any state, territory, district or possession of the United States, or any foreign country, to the extent that these purposes are not forbidden by the laws of the state, territory, district or possession of the United States or by the foreign country.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of Common Stock having a par value of one dollar (\$1) per share.

ARTICLE V - DURATION

This corporation shall have perpetual existence commencing on the date these Articles are filed with the Secretary of State.

ARTICLE VI - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share

thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

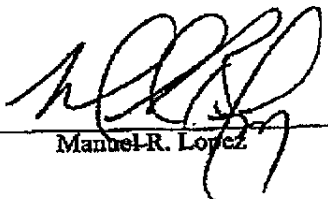
The corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

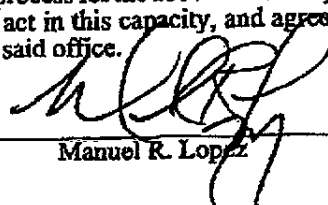
